- (3) Survey of the site depicting the perimeter property lines and area within the property to be vacated.
- (4) A copy of the legal description in MS Word and PDF versions.
- (5) Signed PDF of the subject property owner consent form.
- (6) A surveyor should stake the area on the site to be vacated for utility company review on their site visit.
- (7) A letter addressed to the City Council describing the scope, nature, and intent of the request.
- (8) Petition to vacate easement (sample petition is attached).
- (9) Comments from all utility companies concerning the easement to be vacated and its relationship to existing or planned utilities with recommendations as to what action should be taken (an example comment form is attached) is required at application submittal.
- (10) ACCESS EASEMENTS ONLY: Documentation stating names of all owners of property adjacent to the easement to be vacated. Written consent is required from all adjacent property owners and is required to be submitted with the application. (example form is attached).
