

HISTORY OF THIS MANUAL

This Policies and Procedures manual was approved by the Fayetteville City Council by Resolution Number 3-99 dated January 5, 1999. This resolution rescinded the previous Policies and Procedures manual, which were approved by the Fayetteville City Board of Directors by Resolution Number 110-90, dated July 03, 1990. This resolution rescinded the previous rules and regulations as approved by Resolution Number 91-82 of August 03, 1982.

REVISION #1 was published October 5, 1999, which revised General Order #9 to include security information pertaining to the AS/400, PC=s, laptops and mobile computers.

REVISION #2 was published May 17, 2000, upon approval of the City Council, Policy #33.1.1 (Physical Fitness) was revised, General Order #1 (Updated information) was also revised and General Order #15 was implemented, requiring supervisors to systematically run an AS/400 report to ensure officers are completing case reports.

REVISION #3 was published June 06, 2001, upon approval of the City Council, Policy #33.1.1 (Physical Fitness) was revised, General Order #11 (Stop Stick) was created to establish specific guidelines for the deployment and use of the "stop stick" devise on July 12, 2001 and General Order #16 (Internet policy) was created to establish guidelines for internet use on July 12, 2001.

REVISION #4 was published April 11, 2002, which added General Order #17 creating the Quartermaster System.

REVISION #5 which added General Order #18 establishing guidelines for off-duty employment and General Order #19 implementing the Paperless Automated Case Entry System (PACE) as the primary police reporting system.

REVISION #6 was published August 11, 2003 which added General Order #20 establishing guidelines for the proper uses of the Emergency Restraint Chair, General Order #21 creating the Chaplaincy Program, General Order #22 which established procedures and guidelines for using the Mobile Video/Audio Recording Equipment, and Policy 1.2.3 which reaffirms the department policy against racial profiling.

REVISION #7 was published February 8, 2005, which added General Order #24 establishing guidelines for the use of "A Child is Missing" and General Order #25 establishing proper procedure for the use of the "*Morgan Nick* Amber Alert System"

REVISION #8 was published April 6, 2006, which updated General Order #23 and renamed it to "Conducted Energy Weapons (CEW)."

REVISION #9 was published August 1, 2006, which updated General Order #02 to current FLERS procedures.

REVISION #10 was published June 19, 2007, upon approval of the City Council, Policy 1.2.1 was revised to include a section on the arrest of foreign nationals and establishing guidelines for officers making an arrest outside their jurisdiction. Both of these additions were required to comply with state law. Revision #10 also revised General Order #03 by removing the seniority list, renaming Assistant Chief of Police to Deputy Chief of Police, and adding the ranks of Captain and Corporal to the Chain of Command structure.

REVISION #11 was published July 1, 2008. Upon approval of the City Council, Policy 1.2.3 was revised to include language which brought the policy into compliance with state law. The substance of the policy did not change. However, references to other areas of the policy manual were added.
